## UAE Minister of State for Future Food Security approves ICBA's new board of directors

He has held key positions in different organizations, including the Director of CGIAR based at the World Bank in Washington, DC, USA, and Assistant Director General of FAO's Agriculture and Consumer Protection Department.

Prof. Quentin Grafton is Chairholder, the UNESCO Chair in Water Economics and Transboundary Water Governance. He is also Professor of Economics, ANU Public Policy Fellow, Fellow of the Asia and the Pacific Policy Society and Director of the Centre for Water Economics, Environment and Policy (CWEEP) at the Crawford School of Public Policy at the Australian National University.
